15.9k originations totaling \$1.8 billion

BUSINESS INVESTMENT



Of that activity, 14.3k loans and investments totaling \$662.7 million went to Alabama businesses, nonprofits, and community facilities, with the balance going to individuals and families.

1.4k consumer loans totaling \$289.4k

MANUFACTURING



25 loans and investments totaling \$12.1 million to manufacturing and industrial businesses

- There are 42 certified CDFIs headquartered in Alabama, including 29 banks, 10 credit unions, 2 loan funds, and 1 venture capital fund.

- The CDFI Fund has awarded a total of \$145
 million in financial assistance to Alabamaheadquartered CDFIs along with \$465 million
 in NMTC allocation and CDFI Bond awards to
 CDFIs and CDEs headquartered in Alabama.
