#### **TOTAL INVESTMENT**



42.3k originations totaling \$5.1 billion

#### **JOBS**



55.4k permanent FTE jobs 41.2k construction jobs

#### **BUSINESS INVESTMENT**



Of that activity, 32.4k loans and investments totaling \$1.7 billion went to Louisiana businesses, nonprofits, and community facilities, with the balance going to individuals and families.

#### **REAL ESTATE**



34 million sq. ft. of commerical real estate constructed or rehabilitated

#### **MANUFACTURING**



131 loans and investments totaling \$64.6 million to manufacturing and industrial businesses

#### **HOUSING**



6.5k home purchase and improvement loans totaling \$1.1 billion, including \$37.3 million to 84 first-time homeowners



6.9k affordable housing units financed

- There are 105 certified CDFIs headquartered in Louisiana, including 73 banks, 28 credit unions, 4 loan funds.
- There are 452 CDFI branches in Louisiana.
- The CDFI Fund has awarded a total of \$385.5
  million in financial assistance to Louisianaheadquartered CDFIs along with \$3.9 billion
  in NMTC allocation and CDFI Bond awards to
