# High Level Fiscal Situation

- ▶ **Administration Priorities for Budget Reconciliation**
- ▶ Extend the Tax Cut and Jobs Act (TCJA) of 2017 (\$4 Trillion)
- ▶ Border Security (\$90 billion)
- ▶ **Offsets**
- ▶ Expand Oil and Gas Exploration
- ▶ Eliminate/Curtail Climate spending and certain tax credits enacted in the Inflation Reduction Act
- ▶ Reduce Domestic Discretionary Spending ( Appropriations) and Mandatory Spending ( SNAP, Medicaid)
- ▶ Debt Limit

# CDFI Appropriations

- ▶ Fiscal Year 2024(FY 24) Final: **\$324 million**
- ▶ Fiscal Year 2025 (FY 25) Budget: **\$324.9 million**
- ▶ Fiscal Year 2025 House: **\$276.6 million**
- ▶ Fiscal Year 2025 Senate: **\$354 million**
- ▶ Fiscal Year 2025 Final: American Relief Act (the CR) extends most federal programs through March 14, 2025

## What's Next ? Next 30-45 Days

- ▶ Trump Administration weighs in FY 25 priorities.
- ▶ House FY 25 Appropriations Bill: \$100 million below FY 24 and the Senate FY 25.
- ▶ House and Senate pass a CR for the balance of FY 25, which used FY 24 as a baseline, but make changes in individual accounts and programs
- ▶ FY 26 Trump Administration Budget Submission - current best guess is in May or June?



# Executive Orders, DEI, Paused Federal Spending

**January 21** - President Trump issues Executive Order (EO) entitled “Ending Illegal Discrimination and Restoring Merit-Based Opportunity”

**January 27** - OMB issues **temporary pause** in federal financial assistance (obligations and disbursements of all federal grant funds and other activities that may be implicated by the new EO).

**January 29** - White House **rescinds** OMB memo; instructs agencies to consult with General Counsel regarding the EO. EO on DEI remains in effect and agencies are expected to employ it to evaluate grants and programs.

**January 31** - Federal District Court issues **temporary restraining order (TRO)** on any freeze or pause of federal financial assistance through February 3 at 5 pm.

# Executive Orders, DEI, Paused Federal Spending

**February 3 - Federal judge expands scope of initial TRO to block the Administration from “implementing, giving effect to, or reinstating under a different name the directives” in the original OMB memo.**

OMB ordered to provide the court with status report on compliance by Friday (Feb. 7).

Open awards that were previously frozen must be released.

**Ongoing - Reports of agencies issuing “stop work” or suspension of contracts, including for technical assistance, evaluation, research, etc.**

# High Level Fiscal Situation

## State of the Union on March 4

### Why Budget Resolution and Budget Reconciliation Matter?

House Republican Leadership failed to reach consensus on Budget Resolution. Senate may move on Budget Resolution first.

### Administration Priorities for Budget Reconciliation

- ▶ Extend the Tax Cut and Jobs Act (TCJA) of 2017 (\$4 Trillion)
- ▶ Border Security (\$90 billion)
- ▶ Expand Oil and Gas Exploration
- ▶ Eliminate/Curtail Climate spending and certain IRA tax credits
- ▶ Reduce Domestic Discretionary Spending and Mandatory Spending
- ▶ Debt Limit

# Appropriations

## Current Status:

- ▶ Currently on a Continuing Resolution (CR) for FY 2025 - On December 20 Congress passed HR 9747 by a vote of 341-82; 209 Democrats/ 132 Republican in favor, which funds the federal government through March 14, 2025.

## CDFI Appropriations:

- ▶ Fiscal Year 2024 Final: **\$324 million**
- ▶ Fiscal Year 2025 White House (Biden) Budget: **\$324.9 million**
- ▶ Fiscal Year 2025 House: **\$276.6 million**
- ▶ Fiscal Year 2025 Senate: **\$354 million**

# FY 25 Appropriations Process

- ▶ Requires Compromise between the House and Senate levels: House Domestic Spending \$100 billion below the Senate and \$70 billion less than a freeze (FY 24 rate)
- ▶ While the final bill may be referred to as a CR, the bill will include appropriations for programs that do not reflect the FY 24 rate
- ▶ What we are hearing on the Hill
- ▶ Republican Challenge: 36 members who would likely not vote for a CR (without significant cuts) or a debt limit increase
- ▶ Very likely final FY 2025 appropriations bill/CR will require Democratic votes in the House



# CDFI Appropriations

## CDFI Appropriations:

- ▶ Fiscal Year 2024 Final: \$324 million
- ▶ Fiscal Year 2025 White House (Biden) Budget: \$324.9 million
- ▶ Fiscal Year 2025 House: \$276.6 million
- ▶ Fiscal Year 2025 Senate: \$354 million (CDFI Coalition request)
- ▶ Fiscal Year 2026 White House (Trump) Budget: not submitted

# FY 25 Appropriations

- ▶ Current CR (Continuing Resolution) expires March 14.
- ▶ House Leaders and White House pushing a “Clean CR” for the rest of the fiscal year, which funds most programs and accounts at the FY 24 rate.
- ▶ The Clean CR will likely include anomalies or changes proposed by OMB last week. Nothing is proposed for the CDFI Fund.
- ▶ The White House is lobbying conservative House Republicans to vote for the CR.
- ▶ House Democrats oppose Clean CR. Senate Democrats divided.

# What Is Happening with Budget Resolution & Budget Reconciliation ?

## Why is this important?

- Passing a budget resolution is the first step in the reconciliation process that allows Congress to pass legislation that bypasses the 60 vote Senate filibuster.

- On February 22, the Senate passed first of two budget resolutions, S. Con Res. 7 - set spending and revenue levels for FY26 - FY34.
- Bill passed by a vote of 52-48.
- First Senate Resolution has a limited scope.
- Does not include an extension of the Tax Cuts and Jobs Act of 2017 (TCJA).

- The Senate is expected to mark up a second budget resolution mirroring much of the scope of H. Con Res 14.
- Senate Budget Committee & full Senate will hash out spending &<sup>7</sup>revenue reductions.

# What is Happening with Budget Resolution & Budget Reconciliation ?

- On February 25, House passed H. Con. Res. 14, the Budget Resolution for the same time period, by a vote of 217-215.
- Assumes at least **\$1.5 trillion** in reductions to mandatory programs and a **\$4 trillion** reduction in tax revenue
- Provides for a dollar-for-dollar increase in revenue reductions, contingent on additional spending reductions of up to **\$2 trillion**
- House's "one-bill" approach combined both an extension of the TCJA and provisions related to the border and defense

- After Senate passes a budget resolution addressing expiration of the TCJA, a House-Senate conference committee will prepare a conference report with a final budget resolution.
- Conference report will include instructions to House and Senate committees to prepare budget reconciliation legislation that achieves spending and revenue targets. That final budget resolution heads to both houses for one final vote.

# FY 26 Appropriations

- ▶ President's Budget will be submitted to Congress likely sometime before end of April
- ▶ Expect Administration to present DOGE savings estimates and estimates on sale of significant federal real estate
- ▶ The CDFI Coalition is recommending a FY26 Appropriations request of \$324 million - level with FY24
- ▶ Many House Members and Senators have posted appropriations requests forms on their websites, with varying deadlines.
- ▶ House mark-ups likely in late April or May

# CDFI Fund and Administration Initiatives

- ▶ Current understanding of reviews of FA and NMTC applications: ongoing
- ▶ Executive Orders continue to be issued and lawsuits continue to be filed
- ▶ Staffing cuts, particularly to probationary employees and employees working on “DEI” - have not rolled out yet at every agency
- ▶ As of today, CDFI Fund staff has not been cut to the best of our knowledge
- ▶ Some agencies have had contracts terminated; As of today, CDFI Fund has not had any contracts terminated or paused, to the best of our knowledge
- ▶ Other federal agencies facing office closures outside of Washington and sales of office buildings in Washington while a return to office has been required

# What is on the tax table

TCJA (Tax Cuts and Jobs Act) Extension - estimated to cost \$4 trillion over 10 years.

TCJA is the top priority for House and Senate leaders.

President has proposed several other tax breaks with a 10-year cost of over \$2 trillion, including eliminating:

- Tax on tips: \$118 billion
- Tax on Social Security: \$1.6 trillion
- Tax on overtime: \$680 billion

These provisions plus other provisions, including NMTC extender legislation, increases cost of the new tax bill to **over \$6 trillion**.

# How to deal with \$6 trillion - Use Current Policy Baseline

- ▶ Extending all TCJA provisions and finding additional spending reductions to offset some revenue loss is a challenge.
- ▶ Some Congressional leaders support using a *current policy baseline* in budget reconciliation legislation.
- ▶ This approach assumes that extending TCJA does not increase costs; it simply extends the current law.
- ▶ Unprecedented Approach


# Can Current Policy Baseline Work?

Some House Members argue that it obscures the cost of tax legislation. It is also not without its obstacles. Suppose the current policy baseline is included in the final budget reconciliation legislation. In that case, it may be deemed to violate Senate rules and could be ruled out of order by the Senate Parliamentarian.

A ruling by the Senate parliamentarian can be overturned by a simple majority vote (the "nuclear option"), which the Senate rarely—if ever—uses.





# Fiscal Year 2025 Appropriation

- March 14, Congress passed H.R. 1968, the Continuing Appropriations and Extension Act
- For the CDFI Fund, directs the continuation of the FY24 level of **\$324 million** in appropriations for the CDFI Fund and **\$500 million** in CDFI Bond Guarantee Authority for FY 2025.

# Budget Resolution and Reconciliation

## Why is this important?

- Passing a budget resolution is the first step in the reconciliation process that allows Congress to pass legislation that bypasses the 60 vote Senate filibuster. It will allow Republicans to pass the associated bills without help from Democrats.
- House and Senate must adopt identical budget resolutions

- On Saturday, the Senate passed a new budget resolution:
  - Makes the 2017 TCJA tax cuts permanent
  - Authorizes \$1.5 trillion in additional tax cuts
  - Raises debt ceiling by as much as \$5 trillion
  - Floor for spending cuts is about \$4 billion
- Resolution uses the “current policy baseline” as its accounting mechanism rather than the “current law baseline” as required under the 1974 Budget Control Act
- *Major difference from the initial House budget resolution, which called for at least \$1.5 trillion in spending cuts over 10 years*
- Senate passed by 51-48 vote, with Senators Susan Collins of Maine and Rand Paul of Kentucky voting against

# Budget Resolution and Reconciliation

- President Trump endorsed the Senate-adopted budget resolution on Monday night
- The House is considering the Senate budget resolution this week
- Several House Republicans are opposing the resolution or have voiced serious concerns, especially because of the lower Senate spending cuts and the use of the “current policy baseline.”
- Senate budget resolution cut target is a floor so House bills could cut much deeper and still be in line with the budget resolution
- House Speaker Johnson can only afford to lose three Republican votes.
- Pressure to act this week before the two-week Easter recess

# Tax Bill

- ▶ TCJA (Tax Cuts and Jobs Act of 2017) Extension costs approximately \$4 trillion
- ▶ Additional Trump tax proposals (\$2 trillion):
  - Eliminating the tax on tips: \$118 billion
  - Eliminating the tax on Social Security \$1.6 trillion
  - Eliminating the tax on overtime: \$680 billion
- ▶ Adding this amount to the TCJA and other provisions, including community development tax incentive legislation, reduces federal revenue by over \$6 trillion.


# March 14 Executive Order

- ▶ Issued very late on Friday night, March 14
- ▶ References CDFI Fund and a few other unrelated entities
- ▶ “Continuing the Reduction of the Federal Bureaucracy”
- ▶ Requires agency to
  - Eliminate non-statutory functions
  - Reduce statutory functions to the minimum required by law
- ▶ Agencies to Report to OMB by March 21

## WHAT WE KNOW SO FAR -

- ▶ Budget cuts domestic programs by \$167 billion (22 percent) and shifts that money to Defense and Border Security.
- ▶ President's "Skinny" Budget proposes to reduce the CDFI Fund by \$291 million, proposes \$100 million for a rural program, and \$33 million for the Administration of existing grants, Bond Guarantee, and New Markets Tax Credit.

## RELEASE OF COMPLETE FISCAL YEAR 2026 (FY 26) BUDGET

- ▶ President's Full Budget Released sometime in June
- ▶ House Appropriations Committee: 302 (b) Allocations
- ▶ House mark-ups in June/July; floor action possible
- ▶ Most Senate mark-ups in September
- ▶ CR likely for the beginning of FY 26

# Status of Budget Reconciliation Legislation and Tax Bills

- ▶ House Budget Committee reported out after some initial challenges on Monday. Full House may consider the bill this week; House Freedom Caucus (HFC) is opposing the bill
- ▶ President Trump meets with HFC at 3 today
- ▶ Rep. Johnson still contends he can get a bill this week, before Memorial Day recess
- ▶ Beginning during the week of June 2, it's the Senate's turn. Initial hopes were for final passage in the Senate by the July 4 recess.
- ▶ Final passage delayed until the end of July, when the debt limit expires.

# Expected key provisions of House “Beautiful Bill”

- ▶ Permanency for all TCJA (2017) tax cuts
- ▶ Increase of the SALT (State and Local Taxes) limits
- ▶ Inclusion of President’s campaign promises of no taxes on overtime and tips
- ▶ New Markets Tax Credit Extension not included in the House Bill
- ▶ Continued debate over Medicaid - implementation and timing of work requirements, pushes for deeper cuts

# Appropriations and Tax Bill Updates

# FY 26 Appropriations

- ▶ President's proposed budget maintains the same level of discretionary spending as in FY 25 - reallocates funds by cutting domestic programs by \$167 billion (22 percent) and shifting that money to Defense and Border Security.
- ▶ President's “Skinny” Budget proposes to reduce the CDFI Fund by \$291 million, proposes \$100 million for a rural program, and \$33.146 million for administrative costs related to CDFI Fund operations, administration of the new Rural Financial Assistance Program, Bond Guarantee, New Markets Tax Credit, CDFI Certification and administration and closeout of programs proposed for elimination.

# What Comes Next on Appropriations

## GETTING TO A FY 26 BUDGET BILL

- ▶ Unclear if President's Full Budget will be released
- ▶ House Appropriations Committee: 302 (b) Allocations – no movement
- ▶ House mark-up for Financial Services and General Government delayed now; has not yet been rescheduled

- ▶ Pravina Raghavan, Director of CDFI Fund, has resigned. Her last day is this Friday.
- ▶ Director of Compliance also leaving
- ▶ Dan Aiello, senior policy advisor, also departing - his departure is for personal move and was in the works for a long time
- ▶ FY 26 Budget does not assume reduced staffing

# FY 25 Funding - OMB Apportionment and release of funds

- ▶ For any agency or appropriated entity, once Congress passes Appropriations bill or CR and President signs it, OMB “apportions” the funding to the agency.
- ▶ Each agency has to have an OMB-approved plan on how they will use their budgetary resources - so it might impact the timing of when grants are delivered, discretion on projects, etc.
- ▶ If an agency exceeds their apportionment (even if they have been appropriated \$), their managers can be subject to the Anti-Deficiency Act.
- ▶ OMB has not apportioned funding for the CDFI Fund so they cannot release any awards as of now.
- ▶ Some other federal agencies or programs are also having their apportionment held up or slowed down.
- ▶ FY 25 CR made the CDFI Fund appropriation available in both FY25 and FY26.
- ▶ The FY 26 Budget appendix indicates that \$289 million, of the \$324 million appropriation will not be obligated in FY 25 or FY 26.

# What can we do?

- ▶ We asked all of you to sign a letter to Secretary Bessent by 5 pm yesterday asking Treasury to announce its commitment to make awards with the FY 25 appropriation and provide a timetable for making awards
- ▶ We asked for clarification on status of FY 25 Capital Magnet Fund, Bank Enterprise Awards and Small Dollar Loan applications – none of which have opened yet.
- ▶ Sen. Warner's office is working on a bipartisan letter to ask Secretary Bessent for the CDFI Fund to award and spend the funds that they were provided in the FY 25 appropriations bill.
- ▶ And we are asking you to engage with your House members and Senators

# Taking Action right after July 4<sup>th</sup>! Contact House Members and Senators

- ▶ Starting the week of July 7<sup>th</sup>, please contact ALL your House Members and Senators to call and ask Secretary Bessent to have the CDFI Fund award and spend the funds they were provided in the FY 25 Continuing Resolution.
- ▶ Talking points:
  - ▶ Congress appropriated \$324 million to CDFI Fund in the CR passed on March 14.
  - ▶ CDFI Fund accepted applications for its Financial Assistance Awards on March 21.
  - ▶ CDFI Fund has not opened applications for other CDFI FY 25 programs including the Bank Enterprise Awards (BEA), the Small Dollar Loan Program and the Capital Magnet Fund.
  - ▶ CDFI Fund has not provided any schedule related to those applications or to the announcement of the successful financial assistance award applications, which they invited.
  - ▶ Our understanding is that OMB has not provided an apportionment to the CDFI Fund - so they have not authorized them to spend the money that Congress appropriated and the President signed.
  - ▶ In addition, President Trump's FY 26 Budget Appendix states that there will be \$289 million in grant subsidies in the CDFI Fund that will not be distributed. This appears to refer to the FY25 appropriations from Congress that the President signed. It is not ok for the Administration to withhold approved funding.



Dear Director Vought,

We write to request information on the Office of Management and Budget's efforts to deploy FY25 funding provided to the CDFI Fund. As you know, *the Full-Year Continuing Appropriations and Extensions Act of 2025* appropriated \$324 million for the CDFI Fund and prescribed those funds to support over 1,400 CDFIs in rural and urban communities. As your Office seeks to implement and execute on this funding legislation, we urge you to swiftly obligate all discretionary funding provided by Congress to the CDFI Fund in a timely manner.

Since its inception over three decades ago, the CDFI Fund has proven critical to the CDFI sector's success and has met the mission to create a public-private partnership to promote access to capital in our most underserved rural and urban communities. Each year, CDFIs leverage federal dollars from the CDFI Fund with private-sector investment to boost small business formation, increase housing production, and deliver new capital to America's forgotten communities.

It's imperative that congressionally-approved funds for the CDFI Fund are deployed strategically and in a timely manner. Delay in the obligation of funds hinders critical projects in our states and could constrain the flow of capital to businesses and consumers who need it the most. To date, the CDFI Fund has yet to announce and disburse awards for five programs within its portfolio even though application periods closed months ago. Furthermore, other programs have yet to publish applications for the current fiscal year.

The uncertainty around the deployment of federal funds from the CDFI Fund is concerning but can be addressed expeditiously. Therefore, we request that your Department issue a spending plan to Congress outlining the timelines for the obligation of all discretionary funds. The plan should provide Congress and the CDFI community with certainty that there will be continuity in the programs that have been lawfully funded.

Thank you for your consideration of our request. We stand ready to work with your Administration to support CDFIs and the communities that they serve.

- ▶ Appears President's Full Budget Document will not be released; Agencies already working on FY27 (next year).
- ▶ House Appropriations Committee: 302 (b) Allocations released last week.
- ▶ Full House Appropriations Committee markup of FSGG expected in September.
- ▶ Small Possibility for Senate FSGG to mark-up before August recess; Expect FSGG and most Senate mark-ups in September.
- ▶ CR likely for the beginning of FY26 and quite possibly for the full year, **but further recissions also likely.**

# Rescission Bills

- ▶ First Rescission Bill, cutting total of \$9 billion in appropriated funds from Foreign Aid and the Corporation for Public Broadcasting, was passed last week
- ▶ Administration has indicated they will recommend more rescission bills soon.
- ▶ Given House is recessing until Labor Day as of tonight, we would expect those new rescission bills in September.
- ▶ **Do not expect any advance notice of what agencies will be targeted with rescissions of already appropriated funds from, but we are concerned that the CDFI Fund could be on the list, especially since OMB is holding up funding.**
- ▶ We need you to continue your on-the-ground advocacy and relationship building with all your Representatives and Senators and their staff, especially during the August recess! It is imperative to do additional outreach to Republican members and Senators!



# FY26 Appropriations - President's Budget


- Provides \$33 million for ongoing Salaries and Expenses and continues CDFI Certification, CDFI Bond Guarantee and New Markets Tax Credit administration.
- Provides \$100 million in “Rural Financial Award Program” to the CDFI Fund to provide “access to affordable financing and spur economic development in rural America.” Requires that 60% of CDFIs’ loans and investments go to rural areas.
- Cuts all “discretionary grants” (\$291 million) from the CDFI Fund. Issues raised includes no need for “seed funding” and racial justice and climate.
- Listed on the Administration’s “Woke Programs,” with a particular focus on the equitable recovery program and efforts on racial justice and climate funding.
- No comment on the Capital Magnet Program
- Administration proposes significant cuts or termination in programs across the federal government used by CDFIs and their customers

# Key provisions of final tax “Big Beautiful Bill”

- ▶ Permanent Extension of:
  - ▶ NMTC
  - ▶ Opportunity Zones
  - ▶ LIHTC expansion
  - ▶ Several Business Credits
- ▶ CBO provided final estimate this week - net cost of \$3.4 trillion increase to the deficit and 10 million people lose health insurance.
- ▶ Cuts to SNAP, Medicaid, clean energy, student loans and increases for military and immigration enforcement/ICE. (A net of \$1.1 trillion in cuts)
- ▶ Extends the 2017 tax cuts permanently and provides tax deductions for tips and overtime for 4 years. (\$4.5 trillion in decreased<sup>24</sup> revenue)

Dear Chairman Hagerty and Ranking Member Reed:

We write to request that no less than \$325 million be provided for the Department of the Treasury's Community Development Financial Institutions Fund (CDFI Fund) in the fiscal year (FY) 2026 Financial Services and General Government Appropriations measure. The CDFI Fund generates economic opportunity in distressed areas by expanding access to credit, capital, and financial services through the investment in and assistance to a nationwide network of Community Development Financial Institutions (CDFIs).

The Riegle Community Development and Regulatory Improvement Act of 1994 (Pub. L. 103-325), established the CDFI Fund in 1994. Since then, it has awarded more than \$7.4 billion to CDFIs, community development organizations, and financial institutions through its funding programs, allocated \$76 billion in tax credits through the New Markets Tax Credit Program, and more than \$2.5 billion in bonds have been guaranteed through the CDFI Bond Guarantee Program.

Through its unique public-private partnership model, the CDFI Fund's award recipients successfully leverage billions in private sector investment to create jobs, build affordable housing and essential community facilities, as well as invest in neighborhood revitalization initiatives.

Since 2010, CDFI Program Financial Assistance award recipients have originated more than \$170 billion in loans and investments, all in communities lacking access to traditional lending or banking institutions or experiencing pervasive disinvestment. These resources have financed nearly 585,000 businesses, as well as the development of more than 425,000 affordable housing units. In Fiscal Year 2024, CDFI program awardees made over 1.054 million loans or investments totaling more than \$24 billion. CDFIs also financed over 45,000 affordable housing units.

In addition to their extensive history of investment in rural and urban communities across all 50 states—as well as the District of Columbia, Guam, and Puerto Rico—CDFIs in recent years have more than proven their value as economic first responders and catalysts for private sector collaboration. The modest increase in requested CDFI Fund appropriations—roughly \$1 million

over FY 2024 spending—alongside an increased role from the private sector, ensures CDFIs can build on their record of investment in underserved communities. The amount requested also ensures that the CDFI Fund will continue to support innovations that advance the technology capabilities of CDFIs, increase liquidity and access to capital markets, and foster efficiencies in the community development field.

It is for these reasons we strongly urge the continued investment in the work of the CDFI Fund by providing it with an FY 2025 appropriation of at least \$325 million.

# NDAA (National Defense Authorization Act)

- **Vehicle for CDFI related authorization amendments; Leadership approved for inclusion in the 2<sup>nd</sup> manager's package**
- **CDFI Fund Transparency Act (Daines/Warner)** - Requires the Treasury Secretary (or designee) to testify annually before the Senate Banking and House Fin. Services Committees re the operations of the CDFI Fund during the previous fiscal year.
- **CDFI Bond Guarantee Improvement Act of 2025 (Rounds/Smith)** - Bipartisan bill to extend CDFI Bond Guarantee Program authorization for 4 years and expand access to it. The bill would reduce minimum loan size to \$25 million and remove the annual limit on guarantees.
- **Scaling Community Lenders Act (Warner/Crapo)** -Authorizes the Treasury Secretary to use dividends from the Emergency Capital Investment Program to fund the long-dormant Section 113 of the Riegle Act of 1994 – the CDFI liquidity enhancement pilot program – which award funds to private sector liquidity facilities that help build capacity of CDFIs.
- **Rural Housing Service Reform Act of 2025 – SEC. 301. Native CDFI Relending program.** (Smith/Rounds).- Would help more Native families achieve homeownership by expanding an existing USDA pilot program, in which the USDA partners with Native CDFIs to leverage their deep ties in local communities and deploy loans to eligible Native borrowers.



# Shutdown and RIF Update

# Shutdown – where we are today

- Last night, the Senate failed to pass the House-approved CR to fund government through Nov. 21 in a 55 – 45 vote – falling short of the 60 votes needed. The House is still in recess, so the only bill that could be considered to avoid a shutdown on October 1 was the House Bill.
- The vote was largely on partisan lines, with Sen. Cortez Masto (D-NV) , Sen. Fetterman (D- PA) and Sen. King (I-ME) joining the Republicans and Sen. Paul (R-KY) voting no.
- Democrats are demanding extension of ACA healthcare subsidies and reversal of Medicaid cuts passed in the OBBA as a condition for any Continuing Resolution. Republicans want a clean CR through Novembers to give time for negotiations.
- The Shutdown applies to programs which are funded by discretionary appropriations that have lapsed and are deemed "non-essential" . Some "non-essential" programs have been previously funded for FY26, such as Defense programs funded through the OBBA. Trump Administration has changed categorization of "essential" functions and included many more – like Tarriff Administration, that are their priorities but not previously deemed essential.

# Shutdown – what it means for the CDFI Fund

- The CDFI Fund has two year programmatic funding. The CDFI Fund, as a whole, under traditional definitions is not considered "essential", with possible exceptions for a few employees.
- AMIS, CMIS and the CDFI Fund website will be available during the shutdown, but no updates will take place. AMIS Help Desk will respond to technical issue questions, but not compliance, certification of programmatic questions.
- OMB sent a memo to federal agencies instructing them to draft plans for mass layoff (RIF notices) in the event of a shutdown for employees whose work is funded by discretionary appropriations that would lapse, especially those that do not align with President's priorities.
- **The CDFI Fund was on this OMB list, however the CDFI Fund does not meet the criteria established in the OMB memo. The clear availability of appropriations and statutory authority, along with the many initiatives in process, should exempt the CDFI Fund from the OMB Directive.**

# Shutdown – what we should see this week

- In a Tuesday guidance memo, OMB Director Vought said that federal employees should “report to work (on today, October 1) for their next regularly scheduled tour of duty to undertake orderly shutdown activities.” He added that federal agencies “should continue to closely monitor developments, and OMB will provide further guidance as appropriate.”
- The threat of the mass RIF is unprecedented. We are reaching out to Treasury and the Hill to understand their strategy and insights. We will talk more about what action you can take in a few minutes.
- How long will the CR last? Expect it to be several weeks, at a minimum.
- What will resolve the Shutdown?

# Supplemental Application and FY 25 Funds Update

# Supplemental Application/Amended NOFA

- Supplemental FA Application released by the CDFI Fund.
- Notification already provided to applicants for FA, TA and NACA assistance who advanced to Step 4 in evaluation process (Eligible CDFIs) to reopen their applications if desired.
- Eligible CDFIs that applied for FA, HFFI, or NACA awards earlier this year and whose application is reopened will have until October 27, 2025 to submit an amended application through AMIS.
- Eligible CDFIs who have not already submitted an application for reopening can continue to request to reopen applications. These requests will be processed after the shutdown is over. Watch for additional instructions once the federal government reopens.
- Treasury also communicated that OMB has agreed to apportion FY25 Funds, but has not committed to a specific timeline of disbursement. They have not yet made the apportionment.

## Changes for Supplemental Application include:

1. The first sentence of Section II.C.1 of the NOFA includes “Climate-Focused Financing” in the list of eligible activities for awards under the NOFA. **The CDFI Fund is amending this list to remove the reference to “Climate- Focused Financing.”**
2. The NOFA defines “Eligible Market” to include, among other things, individuals that are African American, Hispanic, Other Pacific Islander, Filipino, or Vietnamese. **The CDFI Fund is removing these portions of the definition. As a result, the fifth sentence of Section II.C.1 of the NOFA, which provides the definition of “Eligible Market,” is amended to read as follows: “Eligible Market is defined as (i) a geographic area meeting the requirements set forth in 12 CFR 1805.201(b)(3)(ii), or (ii) individuals that are Low-Income, Native American, Native Hawaiian, Alaska Native, or Persons with Disabilities.”**
3. The NOFA defines “Healthy Foods” for purposes of the Healthy Foods Financing Initiative—Financial Assistance program. **The CDFI Fund is amending that definition to align it with the policies of the current Administration. Accordingly, in Section II.C.3 of the NOFA, the definition of “Healthy Foods” is amended to read as follows: Healthy Foods: Healthy Foods include nutrient-dense foods and beverages consistent with Executive Order 14212, “Establishing the President’s Make America Healthy Again Commission.”**

## Release of FY 25 Technical Assistance Awards

- Limited number of Technical Assistance Awards funded with FY24 funding were announced yesterday.
- These TA awards to 56 organizations were in response to applications submitted as part of the FY 25 NOFA.
- In the announcement, CDFI Fund stated they anticipate awarding additional TA and FA awards later this winter, subject to funding availability.
- Noted that this announcement represents Treasury's support for institutions that support growth in rural and other underserved markets.

- Waiting on the BEA, CMF, and SDL applications

# Taking Action

## Essential Talking Points

- **THE CDFI FUND DOES NOT MEET CRITERIA ESTABLISHED IN THE OMB MEMO:**
  - The clear availability of appropriations and statutory authority, along with the many initiatives in process, should exempt the CDFI Fund from the OMB Directive.
  - The appropriations for the CDFI Fund do not lapse at the end of FY 25.
  - The Full Year Appropriations and Extension Act, 2025 (PL 119-4) authorized CDFI Fund appropriations of \$324 million to be available in both FY 25 and FY 26.
  - OMB has allotted \$35 million to Treasury for CDFI Fund administration.
- **In response to a March 14 Executive Order, Continuing the Reduction of the Federal Bureaucracy – The White House, Treasury reported on March 21 that the CDFI Fund was operating within its statutory authority.**
- **To advance action on programs funded with discretionary appropriations, the Treasury posted a supplemental application for its Financial Assistance programs on September 25, issued in consultation with OMB, for CDFIs that may wish to revise pending Financial Assistance applications submitted on March 21, 2025. Those revisions are due on October 27.**

## Essential Talking Points

- Applications are still pending for additional Financial Assistance Programs, including the Housing Production Financial Assistance program, which closed on April 4.
- The Fund has yet to publish a Notice of Funding Opportunity (NOFA) for the Capital Magnet Fund (CMF), which is not funded with discretionary appropriations, the Bank Enterprise Award (BEA) Program, and the Small Dollar Loan (SDL) program.
- HR 1, the Big Beautiful Bill Act, provided a permanent extension of the New Markets Tax Credit (NMTC). The CDFI Fund is evaluating applications for a double round, totaling \$10 billion. The CDFI Fund is on track to make awards this fall.



# NDAA Amendment Update

## National Defense Authorization Bill S. 2296 – Sponsors: Daines (R, MT), Warner (D, VA), Rounds (R, SD), Crapo (R, ID), Smith (D, MN)

- Vehicle for CDFI related authorization amendments; Leadership approved for inclusion in the 2<sup>nd</sup> manager's package
- CDFI Fund Transparency Act (Daines/Warner) - Requires the Treasury Secretary (or designee) to testify annually before the Senate Banking and House Fin. Services Committees re the operations of the CDFI Fund during the previous fiscal year.
- CDFI Bond Guarantee Improvement Act of 2025 (Rounds/Smith) - Bipartisan bill to extend CDFI Bond Guarantee Program authorization for 4 years and expand access to it. The bill would reduce the minimum loan size to \$25 million and remove the annual limit on guarantees.
- Scaling Community Lenders Act (Warner/Crapo) -Authorizes the Treasury Secretary to use dividends from the Emergency Capital Investment Program to fund the long-dormant Section 113 of the Riegle Act of 1994 – the CDFI liquidity enhancement pilot program – which awards funds to private sector liquidity facilities that help build capacity of CDFIs.
- Rural Housing Service Reform Act of 2025 – SEC. 301. Native CDFI Relending program. (Smith/Rounds).- Authorizes the existing Native CDFI Relending Pilot Program and sets aside \$50 million annually from USDA direct homeownership loans for use by Native CDFIs to expand homeownership opportunities in Native Communities

  - 26 Senators
  - 79 House Members

# Shutdown – Where we are today

- The Senate failed to pass the House-approved CR to fund government through Nov. 21 in a 55 – 45 vote – falling short of the 60 votes needed.
- The House passed CR, which extended federal spending through November 21, is dead.
- House and Senate leadership are considering a funding bill that would run into January.
- Once the outline of a CR is finally agreed upon, it is likely that the conference report on the FY 26 Agriculture, Veterans, and Legislative Branch will be added to the bill.
- Enactment of the CR, will end furloughs of federal government employees and provide an avenue of reversing the RIFs at the CDFI Fund.
- Once the CR is enacted, there is interest in completing other spending bills – DOD, THUD, Commerce, and Labor-HHS.
- We are awaiting word on a Senate markup of the General Government Financial Services bill. The House bill, 5166, was reported to the floor in July. It includes \$274 million for the CDFI Fund, \$50 million below the FY 25 rate, and roughly double the budget request.
